Did GE buy Alstom?

US-based General Electric has finally acquired the power and grid operations unit from French Alstom, following regulatory approvals in more than 20 countries and regions. The EUR12.35bn deal was agreed by the two companies in 2014, and marks the largest ever industrial acquisition by GE.

The firm has announced that, following the completion of the acquisition, GE Power & Water will combine with Alstom Power to form GE Power.
