Will Brunei Darussalam's energy revenue rise beyond 2016?

Brunei Darussalam's energy revenue is set to rise further beyond 2016 as oil prices continue their modest recovery from a 13-year low earlier this year. In the first quarter Brunei Darussalam saw oil prices drop to \$35 a barrel, down from \$44 at the end of the 2015.
