

Who is Ormat Technologies?

With over five decades of experience, Ormat Technologies, Inc. is a leading geothermal company and the only vertically integrated company engaged in geothermal and recovered energy generation ("REG"), with robust plans to accelerate long-term growth in the energy storage market and to establish a leading position in the U.S. energy storage market.

What does Ormat do?

Ormat leveraged its core capabilities in the geothermal and REG industries and its global presence to expand the Company's activity into energy storage services, solar Photovoltaic (PV) and energy storage plus Solar PV.

What will Ormat's new geothermal facility do?

Located on an island adjacent to Ormat's existing Bouillante power plant in Guadeloupe, the new geothermal facility will allow Ormat to benefit from operational synergies that will reduce manpower costs and strengthen the economic potential of the expected Dominica geothermal project.

Where is Ormat manufactured?

Our most recent manufacturing facility began operating in Turkey in 2017, certified by the Turkish authority for local manufacturing enabling our Turkish customer to enjoy the increased Feed-In-Tariff. How many power plants does Ormat have?

The company has built over 190 power plants and installed over 3,200 MW. As of January 2021 it owns and operates 933 MW of geothermal and recovered energy based power plants. Ormat has supplied over 1000 turbochargers worldwide: North America, South America, Europe, Australia, and Asia.

Does Ormat manufacture power generating unit equipment?

Ormat manufactures most of the power generating unit equipment componentry used in our power plants. We acquire any equipment we do not build ourselves from selected, top-quality, trusted suppliers.
